## > RULES AND REGULATIONS OF SHIVALIK ALUMNI CLUB

#### 1. INTERPRETATION:

In the context of these Rules and Regulations, unless there is something inconsistent with the subject

- a) The "Society" shall mean the SHIVALIK ALUMNI CLUB\_The "Governing Body" shall mean the Governing Body / Executive Committee of the Society constituted as provided by these rules and regulations.
- b) The "Act" shall mean The Societies Regulation Act XXI of 1860, or any modification or reenactment thereof for the time being in force.

## MEMBERSHIP:

## A. Eligibility for Membership: -

- A person who has completed his/her Graduation in any faculty or Post Graduation in any discipline from this college will be eligible for membership.
- iì. A person who left the college after completion of 10+2 stage or before completion of his/her degree by certain reasons but had passed at least one annual exam of the college will also be eligible.
- The minimum age shall be 20 years provided the desirous alumni had not been rusticated from iii. the college.
  - B. Types of Membership:-

There will be three types of membership:-

- Ordinary Member: Will be only for three years and shall pay a subscription of Rs. 200/- only as membership fee for life membership.
- Life Member: Will be required to pay Rs. 1000/- as subscription fee. ii.
- Honorary Member : If Executive Committee by two third majority of the present members iii. desires that any Officer or person who may be helpful for the welfare of the Club can be taken as honorary member. He/She will pay a subscription of Rs. 100/- for two years. However, he will be a non-voting member.

Note: Every member shall fill up the membership/registration form and shall subscribe to the aims and objects of the Club and pledge to abide by the constitution, discipline and decision of the Club.

Disqualification :-

A member of the Club or Executive Committee shall cease to be a member in case of : 1)  $\frac{Death 2}{Death 2}$ 

Non-Payment of Dues 3) On Disciplinary Grounds/anti-club activities/moral turnitude

## 4. "Executive Committee"

The "Executive Committee" shall be duly elected by the "General House" and will consist of the following office bearers:-

- i) Patron :- Principal of the college will be Ex-Officio patron of the Club.
- ii) President, Senior Vice President, Vice President, Joint Secretary and three executive members to be elected/nominated by the members of the Club.
- iii) Secretary, Cashier/Treasurer and three Executive Members to be appointed from the college staff who may be alumni or non-alumni.

Note: The minimum age for becoming the members of Executive Committee shall be 25 years.

## 5. Policy:-

This Club will be purely for the social get-together and for the welfare of the college. It will be a voluntary and non-political body. It will not seek to interfere in the administrative matters of the college.

- 6. Term and Re-election:
  - i. The term of Executive Committee will be two years.
  - ii. The Secretary will ensure that a notice of re-election is given to the members of general body 15 days before the expiry of the term for re-election of the new Executive Committee. The present members in the meeting will elect/reelect the new Executive Committee for the next two years.
    In case of more than one candidate for one post it will be decided by a chit vote by the present members.
    - iii. In case of any eventuality that notice is not given for the election, the term of the existing committee will be extended for a period of not more than three months and it will be ensured by the Secretary that the election takes place immediately but not more than three months from the expiry of the term and the previous committee will continue till a new Executive Committee is elected.

#### Duties of Executive Committee:-

The Executive Committee will suggest ways and means for the benefit of the club and the college.

Any member failing to attend three consecutive meetings without assigning any reason or cause

may cease to be a member of the committee.

- iv. The meeting of the Executive Committee will be called by Secretary quarterly or whenever required after due notice to the members.
- v. The Executive Committee can appoint, suspend or dismiss any member of the Club if He/She is found to take part in anti-club activities or on the grounds of moral turpitude in order to maintain discipline and sanctity of the Club subject to the confirmation/ratification in the next meeting of the General Body.

New Executive Committee will be elected/nominated in the Club's General Body meeting. Any office bearer of previous Executive Committee can be reelected/nominated by the General Body.

vi. The quorum of Executive Committee meeting would be one third or five members, whichever is less, meeting shall be adjourned in there is no quorum.

#### Duties of the Office Bearers :-

A. Patron: He/She will render advice and guidance in the working of the Club.

The resolution book and the minute's register will be counter signed by the patron after every meeting.

The cash book and the stock register will be checked and counter signed annually by the patron.

#### B. President:

- a. He/She will guide, conduct and control the activities of the Club in accordance with the constitution and decision taken by the Club from time to time.
- b. He /He/She will have a casting vote in case of a tie, he will have no vote otherwise.
- c. He/She shall regulate the proceedings of the executive meetings and the General Body, interpret the rules and regulations and give findings on doubtful or contested matters and his interpretation shall be final.
- He/She shall sign the minutes of the meetings and other important documents on behalf of the Club.
- He/She will preside over the meetings of the Executive Committee and the General Body.
- f. President will be the sanctioning authority for any kind of expenditure for the fulfillment of aims and objects of Club subject to the approval by the Executive Committee.

C. Senior Vice- President :

He/She will act as President in the absence of the latter and will have the same powers as those of the President when acting in that capacity.

D. Vice President: He/She will act as senior Vice – President in his absence.

#### E. Secretary:

- a. He/She will carry-out the day-to-day business of the Club and of the various sub-committees.
- b. He/She will call the meetings of the Executive and general Body in consultation with the President and will issue notices and circulate agenda for all the meetings.
- c. He/She will maintain record of all the proceedings of the Club and the executive committee and prepare the report of the activities of the Club and present it in the meetings of the General Body.
- d. He/She will take steps to strengthen the Club and improve its working. He will also attend to any other matter which may be entrusted to him by the President/Executive Committee of the Club.
- e. He/She will buy miscellaneous articles for the maintenance of the office.
- f. He/She will maintain the regular roster of the members of the Club and maintain and keep record of all the correspondence of the Club in the office.
- g. He/She may keep Rs. 1000/- as imprest/Club money with him and spend that sum in anticipation of the approval of the Executive Committee.
- F. Joint Secretary :- He/She will assist the Secretary in his work and will act as Secretary in his absence.

#### G. Treasurer/Cashier:

- He/She will maintain regular accounts of the funds of the Club under the head of income and expenditure.
- He/She will ensure that necessary accounts and vouchers are regularly kept and maintained.
- He/She will operate the bank account jointly with the President.
- d. He/She will prepare annual report of the income and expenditure of the Club, which will be presented at the meetings of the General Body for approval.
- e. He/She will make payments of the bills sanctioned by the President.
- f. He/She will put the accounts and books before the meeting of Executive Committee for scrutiny and before the auditor/charted accountant for checking and accounting.
- g. He/She will prepare budget in consultation with President and Secretary for the approval of the General Body.

8. Fundst-

All the funds/donations of the Club will be deposited in the bank in the name of SHIVALIK ALUMNI CLUB. and account to be operated jointly by the President and Treasurer /cashier. The money will be withdrawn by the joint signatures of the president and Treasurer /cashier. All the funds will be utilized for the welfare of the college, charity show for the college, social get-together among the old students, on the refreshment during meetings and functions, to honour the deserving students, to honour those personalities, who have made lot of contribution in the

development of the college. However, before utilizing the funds executive committee will pass a resolution for this purpose. The financial year of the Club and from 1st April to 31st March of the next year.

#### Minutes Books & Account Books

The record of all the proceedings of meetings will be maintained in the minute's book. The Account Book and Register of members with full addresses will be maintained.

10. General Body :-

All the members of the Club will constitute the General Body of the Club. Meeting of the General Body will normally be held twice a year but it Executive Committee requires, General Body meeting can be called more than twice a year. The quorum of the General Body for the election/nomination purpose will be 10% of the total membership of the General Body. The Secretary shall read the annual report of the work done by the Club and shall declare the date time and place for General Body meeting at least a fortnight earlier.

### 11. Amendments:-

Any amendments in the constitution of Club can be done in the general Body meeting if 75% majority out of the present members vote in favor of the resolution for amendment.

Legal Affairs: - The Club will sue or be sued in the name of President, SAC (Shivalik Alumni Club) Govt.
 Shivalik College, Naya Nangal in any court of law subject to jurisdiction at Nangal.

## 13. CIRCULAR RESOLUTION:

A circular resolution issued by the President on any subject, which it deems urgent and signed by the majority of the members of the Governing Body shall in all respects be deemed to be a resolution passed at a meeting duly convened and constituted and such a resolution shall not be deemed invalid for want of notice, or any other cause, whatsoever.

## 14. AMENDMENT IN THE CONSTITUTION:

These Rules and Regulations and any rules and regulations hereafter made by the Society may, from time to time, be varied, added to or revoked by a majority of not less than ¾ of the members of the Society present at a General Meeting called for the purpose of such variation, addition or revocation. Provided that in the case of any alteration, abridgement or addition to the purposes of the Society or it's amalgamation with another Society, the Provisions of section 12 of the act shall apply.

Adoption of the Constitution - This constitution was passed and adopted by the old students (alumni) of Govt. Shivalik College, Naya Nangal in the meeting held on 25/01 2023 In the college and the constitution became operative from the same date i.e. 25/01/2023.
